The legislative work of the General Conference comes in the form of resolutions written by individuals, annual conference resolution committees', organizations, and general agencies of the church.

Resolutions are submitted to the office of the General Secretary – Auditor and must reach the office at least four months (120 days) prior to the setting of the General Conference.

The report of the Resolutions Committee is the first report heard so resolutions that met the deadline of 120 days can be referred to the appropriate interface committee(s).



INTERFACE COMMITTEE

All Resolutions going before the General Conference should be brought to the floor early on the program agenda specifically when the resolution is referred to the Budget & Apportionment/Finance Committee.

- **You may find this in the 2021 A.M.E. Zion Book of Discipline on page 40; par.'s 120 &121.**
- **Resolutions found to have merit (legal significance) are most often referred to 13 of the various interface committees.**
- **A resolution can be referred to more than one interface committee and those interface committees may deem it appropriate to refer a resolution to another committee before it comes to the floor of the General Conference.**
- **The interface committee presents to the General Conference and forwards resolutions with recommendations to the Revisions Committee.**
- **The report of the Revisions Committee brings forth the resolutions referred to them with recommendations from the Resolution Committee and the various interface committees. Final approval by General Conference.**
